<b>PREVIOUS ACTION:</b> On May 15 <sup>th</sup> , 2024 the MPO Policy Committee approved a motion to receive public testimony and initiated a 20-day public review and comment period for the proposed update.																															
<b>BACKGROUND:</b> <p>The Transportation Improvement Program (TIP), required by federal law, is a short-range program of transportation improvements for the MPO's planning area. The TIP shall reflect the investment priorities established in the current Metropolitan Transportation Plan (MTP) and shall cover a period of no less than 4 years, and be updated at least every four years. Fixing America's Surface Transportation Act (FAST Act) requires that Metropolitan Planning Organizations (MPOs) in cooperation with the State and affected transit operators develop Transportation Improvement Programs (TIP) for their planning areas. These Transportation Improvement Programs then become part of the State Transportation Improvement Program (STIP). As a Transportation Management Area (TMA), the Laredo MPO selects projects funded by 23 U.S.C. and 49 U.S.C. Chapter 53 (excluding projects on the National Highway System (NHS) and projects funded under the Bridge, Interstate Maintenance, and Federal Lands Highway programs) in consultation with the State and public transportation operator(s) from the approved TIP and in accordance with the priorities in the approved TIP. Projects on the NHS and projects funded under the Bridge and Interstate Maintenance programs shall be selected by the State in cooperation with the MPO, from the approved TIP. ## **2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

- Per Federal law, all Metropolitan Planning Organizations (MPOs) are required to develop a Transportation Improvement Program (TIP) for their planning areas for a four-year period, in cooperation with the State and public transit providers.
- Our MPO Public Participation Plan (PPP) requires a 20-day public review and comment period for initial adoption of the TIP.
- The TIP must be fiscally constrained and projects are included only if full funding can be anticipated to be available for the project within the time period contemplated for completion of the project.
- The TIP may be amended by the Policy Committee at any time during its lifecycle. As needed, approved amendments are submitted to the State Transportation Improvement Program (STIP) on a quarterly basis.


